



Talisman Farm lesson package Policies 2024

Lesson packages are to be paid in advance and are automatically renewed monthly. To cancel or suspend your lesson package, **30 day notice required**.

You are not charged for missed lessons IF you **provide 24 hour cancellation notice**, & weather cancellations (as weather can change abruptly cancellation will be provided as early as possible) paying by the lesson, payment must be received **PRIOR** to appointment or appointment held with credit or debit/credit card. Card will only be charged at appointment if you fail to provide 24 hour cancellation notice.

No refund on lesson packages, they can however be transferred over to another party for use. Unused lesson / Packages expire after 60 days and may be extended under certain circumstances.

Payments due 1st of month unless special arrangement have been arranged for 15th due date or payments may be split on the 1 & 15th. **Complete Recurring debit/credit payment authorization form to arrange for monthly recurring payment** date selections. You may pay via ZELLE, however a credit/debit card is required to be on file. If payment not received on due date of 1 or 15th your card will be charged on the 2nd or 16th with late fee of \$50 added. **There are no grace periods!** Non payment will result in immediate suspension of lessons regardless of make ups accrued.

Tardiness - If you are 30 minutes late to your appointment you will be charged for the tardiness and your lesson canceled to not inconvenience other scheduled appointments. Lesson starts at your appointment time. Beginner riders grooming & tacking up is part of your 1 hour lesson, all other students you are responsible for tacking up your lesson horse and being on time for your lesson.

Make ups – You are automatically billed monthly for lessons regardless of make ups accrued, make ups are students responsibility to reschedule. If make ups can not be made up within in 60 days, please advise as invoice will be adjusted on a case by case basis only with weather cancellations taken into consideration.

RECURRING CREDIT/DEBIT CARD PAYMENT AUTHORIZATION
